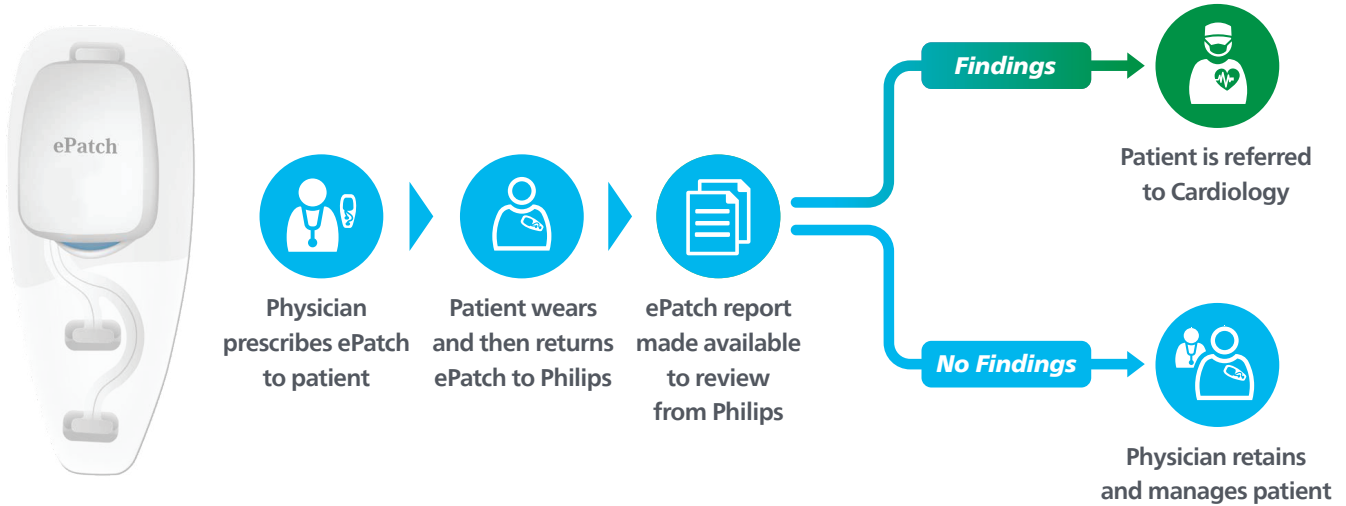

### Wear time:

3 – 14 days single channel with Patch or Flex

3 – 5 days, three channels with Patch, Flex, or Lead wire adapter (LWA)

### Wear options:

Patch, Flex, and LWA

### Age restrictions:

18 years and up only (Patch, Flex, and LWA)

### EMR capabilities:

Order ePatch and e-Sign report

### Device hookup:

In the office or patient performs at home

### Device retrieval options:

Device mailed back to Philips or data uploaded at office (portal)

### Kit contents:

Device, 3 patches or sufficient electrodes, full instruction guide diary, placement template, quick start guide, kit is a pre-paid return package
